A motion to open swim club if 700 members were achieved by Friday, June 19th by Commissioner Springob; second by Commissioner Vassallo. The motion stated only 900 members would be able to join this year. Motion carried, 4 to 3.

Commissioner Vassallo made a motion to offer an option of 10 day passes for \$100 for 2021; second by Commissioner Mazza. Motion defeated, 3 to 4.

Commissioner Mazza made a motion to allow current members of 2020 to prepay more money for 2021 season; second by Commissioner Vassallo. Motion defeated 2 to 5.
