File#2020-06 PSE&G, Grand Avenue (Rear) & Willow Tree Road

The applicant appeared before the board seeking preliminary and final site plan and a temporary permit for incidental use. Board member Mr. Botten recused himself from this application.

Cynthia DeLisi, Attorney for the applicant addressed the board. PSE&G is seeking temporary fencing while work is being done on their property. Once the work is complete they will install new landscaping and permanent fencing. Board Engineer Mr. Costa informed them that if Willow Tree Road is damaged they must repave. They are not allowed to patch the street.

Daniel Kovach was sworn in and gave testimony as the Manager of Product Engineering for PSE&G. Marked were the following:

A-2 Site Plan Leonia substation dated 7/22/2020

The proposed project is a two year operation. They will need a total of 4 trailers. They will provide a portable washing station and have port-o-johns as well. The temporary fence will be 5 feet in height. The construction will not interfere with the high school. All material will be stored on site as will several dumpsters. The board expressed concerns about the look of the area while it is undergoing construction. They would like the trailers moved to a denser area. PSE&G will investigate whether they can be moved because the area is in a flood plain. The crew will consist of about 24 people who will be parking offsite in a separate parking lot.
