Unfinished Business:

COVID-19 UPDATE – Mayor Zeigler

Mayor Zeigler reported that COVID-19 is very active within the State, County, and Leonia. He urged residents to continue to wear face coverings, practice social distancing, and avoid indoor gatherings. With respect to the vaccine, he commented that an order has been placed and it is anticipated that the vaccine will begin to be administered in mid-February. He noted that he has received an overwhelming response to the call for volunteers to assist with the vaccine clinic and it is possible that the hours of operation can be expanded. He expressed his opinion that the State has done a poor job with the vaccine rollout, and as a result, the Borough will be implementing its own scheduling system. He advised that he had a conversation with the Mayor of Tenafly who has agreed to pay part of the cost for supplies and provide volunteers.

Recreation Staffing/Budget Requirements - Mayor Zeigler

Mayor Zeigler explained that he had requested that the Finance Committee review the Recreation Department staffing requirements with the Recreation Commission to ensure that the recommendation for the promotion to Program Director was appropriate.

Councilwoman Flaim confirmed that the committee had a very substantive conversation with Sean Krakower, Recreation Superintendent, and Jon Abouaf, Recreation Commission Chairperson, during which detailed information was provided on the responsibilities assigned to each position within the department. She expressed comfort in what was presented, noting that an alternative was not provided.

Snow/Alternate Side Proposal – Council President Terrell

As Councilman Grandelis has not had the opportunity to obtain data on how many times the ladder truck has had to deploy its outriggers, it was decided to move this discussion to the February Work Session.

Ordinance - Use of Right of Ways - Borough Attorney

Borough Attorney Chewcaskie explained that this ordinance codifies the procedures for review and approval of 5G wireless facilities within the Municipal Rights-of-Way and is consistent with FCC requirements and regulations. He noted that it includes provisions to ensure protection of the tree canopy. He noted that he has prepared an application form and form of agreement which will be implemented upon adoption of the ordinance.

Council President Terrell added that there is language included that will minimize equipment that is left behind when newer equipment is installed.

It was decided to place this ordinance on the February 1st Regular Meeting agenda for introduction.

Discussion on Downtown Analysis & Recommended Actions - Mayor Zeigler

Mayor Zeigler advised that this agenda item will be pushed to the February Work Session.

Council President Terrell expressed concern that no Korean restaurants were interviewed when this analysis was done and asked that doing so be made a priority. Mayor Zeigler advised that this concern will be relayed to Karp Strategies.

CDBG Project Discussion - Mayor Zeigler

Borough Administrator Wardrop explained that the Community Development Block Grant application is due shortly. She suggested that funds be sought for improvements to the Senior Center basement which has extensive flooding issues and resulting water damage. She advised that CDBG has confirmed that this project would be eligible for funding.

Borough Engineer Di Sessa explained that the Senior Center basement door facing Broad Avenue is two feet below grade and extensive water damage to the vinyl flooring exists. He explained the work that would be involved to resolve the flooding issues and advised that a cost estimate has been prepared.
