The Reorganization Meeting of the Mayor and Council of the Borough of Leonia was held virtually via GoToMeeting in the Leonia Borough Hall at 312 Broad Avenue, Leonia, NJ on January 4, 2021. The meeting was called to order a 7:31 p.m. by Mayor Judah Zeigler.

Councilwoman Flaim led those present in a salute to the flag.

Mayor Zeigler asked for confirmation that the Bergen County Clerk has certified the election results of Councilwoman-Elect Maureen E. Davis and Councilman-Elect Pasquale Fusco. The Borough Clerk confirmed same.

Mayor Zeigler administered the Oath of Office to Councilwoman Maureen Davis and Councilman Pasquale Fusco who were joined by their families.

Mayor Zeigler read the following statement into the record: "In compliance with the Open Public Meetings Act, the notice requirements have been satisfied. Notice of this virtual meeting by the December 28, 2020 Sunshine Notice containing the time, date, and access information was sent to the Record, Star Ledger and has been posted at Borough Hall and on the Borough website."

The Borough Clerk called the roll of the 2021 Mayor and Council.

Presentations/Remarks

Councilwoman Davis

Councilwoman Davis expressed a profound thank you to the Borough Administrator, Public Health Nurse, Borough Hall staff, Police Department, Fire Department, Board of Health and

DPW. She reviewed her goals for the next three years which included aggressively pursuing west side development to increase ratables as well as to continue to focus on issues relating to racism and racial equity.

Councilman Fusco

Councilman Fusco commented that he is deeply humbled to serve the residents of Leonia once again and is proud to be a member of this governing body. He congratulated Councilwoman Davis on her reelection. He noted that he is also invested in the development of the west side and is part of the subcommittee that is working on this effort.

Mayor Zeigler's State of the Municipality Address

Mayor Zeigler read the following into the record:

"Members of the Borough Council, Borough Administrator Wardrop, Borough Clerk Dodd, and my fellow Leonians; it is my honor and privilege to once again be with you and to offer you my assessment of the state of our Borough.

My remarks this evening will of course include a look back at the prior year, but even more importantly, will focus on the important priorities of 2021.

There is no question that, for most of us, 2020 has been the most challenging of our lives. A year ago, words like "contact tracing," "rate of transmission" and "spot positivity" were unknown to all but a few of us. We have watched as hundreds of our fellow Leonians were sickened by the COVID-19 virus, and grieved at the death of 13 of our neighbors, lost to its effects. We have endured months of forced isolation, which in turn has caused us to be unable to be together with the family and friends so important to each of us. Our young people have not been immune from these sacrifices; they have been forced to endure long periods of online-only instruction, missed important milestones like senior proms and final high school athletic seasons, missed eighth grade and senior weeks, and have been unable to spend time with their friends.

While certainly the largest, the pandemic has not been the only challenge we've faced this past year; during the spring and summer, civil unrest became commonplace, and racial divisions were intensified. Leonia experienced some of these tensions first-hand, as our attitudes and beliefs, both overt and tacit, were challenged.

In spite of the challenges we have faced, we have learned a great deal about each other, and about ourselves. We have come together as Leonians always do - showing how much we care about each other, and about our community as a whole. During the dark days of the first COVID-19 surge, Leonians, through our Leonia Cares program, stepped forward to offer assistance with shopping and errands – assistance being provided to neighbors that they didn't necessarily know, except that they were fellow Leonians. In addition, the members of Leonia's COVID-19 Task Force, volunteers and paid professionals alike, worked hand in hand with me, seven days a week, to ensure that we continued to refine and optimize our response to the pandemic, and help keep our residents and all who live and work in our Borough healthy and safe. When racial tensions threatened to divide us, hundreds participated in town hall meetings to talk, openly and honestly, about their fears, attitudes and long-held beliefs. In recognition of the importance of continually addressing these issues, I last year formed the Mayor's Advisory Committee on Racism and Racial Equity, as well as the Gen Z Advisory Committee, created for the same purpose. The members of both of these committees have been working incredibly hard to identify solutions and recommendations for this Governing Body to consider, some of which have already been realized. While the

challenges of institutional racism and ensuring racial equity have certainly not been resolved, the work that has been done has allowed us to begin the process of understanding and respecting one another as members of the diverse community in which we live, and I look forward to the continued progress of these dedicated volunteers during the coming year.

We also said goodbye this past year to three long-time members of our municipal government, each of whom have contributed immensely to the fabric of our community. In October, Police Chief Tom Rowe retired after more than two decades of service to Leonia, during which he established a police department reflecting both the diversity of our community and our unwavering commitment to true community policing and engagement. In December, Superintendent of Recreation Barbara Davidson also retired after 24 years leading the Recreation Department, and after 40 years leading the Leonia Swim Club. Finally, and also in December, Jane Barnes, long time library staff member, retired after 39 years of service to our community. All three of these dedicated public servants exemplify all that is and has been right about our town, and we thank them for their service and dedication to Leonia.

Tragically, in August, Leonia lost long-time Fire Department volunteer and ex-Chief Jack Peters, who was also a former member of the Leonia Police Department. Chief Peters dedicated his entire adult life to serve in the community he loved so much, and his family has continued that tradition of service as well. Anyone who knew Jack knew that he was a kind and gentle soul who would literally give a fellow Leonian the shirt off of his back if they found themselves in need; Leonia lost just a bit of its soul on the day Jack passed away, and we hope that he is resting in peace.

As we faced the challenges of 2020, I am proud to say that this Governing Body didn't lose focus on the priorities we had identified early in the year. While we may not have been able to achieve all of the goals we had planned, the work we did has formed a solid foundation for that on which we will be concentrating this year.

From an infrastructure perspective, we, in collaboration with the Leonia Board of Education, completed the construction of a new state of the art athletic facility. Not only do we now have a new multi-sport complex for all who live and attend school in our community, but both due to careful planning and successfully obtaining almost two hundred thousand dollars in grant funding for which the school district, on its own, would not have been eligible, we brought the project in well under its initial projected cost. Our partnership with our colleagues from the Board of Education should be looked upon as a truly best-in- class example of what can happen when everyone works together for the common good. The savings we've realized will allow us to truly complete the project properly; in the first quarter, we will have before us plans for a field house at the facility, which will provide restrooms, storage space, and other necessary amenities to ensure that the facility is used optimally. Adding this building will not result in any incremental cost beyond that which was originally budgeted, and will allow us to maximize potential outside organization use income. I look forward to working together with the Board to complete this important project this year.

In 2020, we also made very significant progress on the construction of our new municipal building, allowing us this year to finally address the deficiencies in our police building and municipal court facility, as well as provide proper facilities for the administrative functions of our municipal government. These issues we are addressing are not new, and while none of us are happy about spending the amount of money we must in order to properly resolve them, the simple fact is that prior administrations completely ignored these matters, hoping they would disappear on their own. They haven't – and this administration cannot continue that history of inaction. I want to commend Councilman Bill Ziegler who, as Chair of the Facilities Committee, serving with myself and Councilman Pat Fusco, has led the work effort

to move this project forward. We will be issuing bids for the project this month, and look forward to breaking ground on it during the first quarter.

As I have said so many times in the past, if we are to survive financially, we have to do things differently. Not only do we have to continue to be stewards of public funds, and maximize the use of every tax dollar with which we are entrusted, we must also seek new sources of revenue to alter the foundational structure of our tax base, and reduce the burden currently felt by all of us, as residential taxpayers. This can only be accomplished if we plan for and encourage responsible development and redevelopment in our community, in a manner different than what we've seen to date. During the past year, we have completed work with an economic development and planning consultant, a firm that has provided us with valuable guidance on the kinds of development that make the most sense for our community, allowing us to maintain our residential character while increasing our ratable base. I look forward to having our consultant share these findings with all of you, and to getting the feedback and input of the public as we formalize recommendations and put in place specific plans to make economic growth a reality.

We are also continuing to address quality of life issues, to ensure that we are being responsive to the evolving needs of all Leonians. We amended our noise ordinance last year, but in my opinion, additional work is needed in this area, so that we can more successfully balance the needs of those who are now working and studying at home with the necessary work that must be completed on our homes and properties themselves. We must also reexamine the manner in which we are addressing property maintenance issues because, in my estimation, not enough progress has been realized, and we are still being reactive, instead of proactive, in our approach to these matters.

Likewise, we will also be addressing the challenges of residential street parking, as well as the frustration expressed by many Leonians regarding our "snow emergency street" restrictions. These are complicated issues, and I want to commend Councilwoman Joanne Terrell for her work, as head of our Laws and Ordinances Committee, in putting forth comprehensive solutions for our consideration. I look forward to spirited discussion of these proposals, early this year, and to adopting sensible ordinance revisions that properly balance the needs of public safety and day-to-day realities.

One area we were not able to address last year was the start of a thorough review of our form of government. As I said last year, I am very concerned that large numbers of voters in our community are being disenfranchised, at the local level, because we currently operate under a partisan form of government. I believe that we must start the process of determining both the feasibility and public interest in changing our form of government to one which is non-partisan, and wherein the only barriers to involvement and participation are interest and ability. This is a multi-year process that will require broad and deep participation by all Leonians – and is something that we should prioritize this year. Accordingly, I will be placing it on our February work session agenda, so that we can collectively determine the best manner in which to proceed.

Of course, all of this work must occur within the context of the continued grip of the COVID-19 pandemic. We know that we are many months away from being able to get back to something truly resembling our "normal" way of life, but if we all work together to follow the legal restrictions and guidelines that have been established, we can minimize the sickness and death that has plagued so many communities in our country, state and region.

What will allow us to escape the pandemic's grip is the broad distribution of the COVID-19 vaccine. Before the first vaccine even received Emergency Use Authorization, I worked with our Public Health Nurse to file an application to have our community designated as a

COVID-19 vaccine Point of Distribution. I am pleased to report that last Thursday, I received a call from the Governor's office, informing me that our application had been approved, which will allow us, in the coming weeks, to begin to offer the COVID-19 vaccine right here in our community.

There are a great many details that must still be finalized, and when we do begin distribution, we will do so in strict accordance with Federal and State requirements as well as CDC guidelines, administering vaccine in prioritized order both to Leonians and those from other communities in our area. To do this, we will need the help of our entire Borough; in the next 1-2 weeks, we will be issuing a call for volunteers to work in various roles at our vaccine administration clinics, and I urge all Leonians who are able and have the background to offer your assistance in ensuring that we are able to serve as a model for efficient and effective vaccine administration, now that we have been approved to administer vaccine locally.

Before I close, I want to express my sincere thanks to each and every Borough employee for their untiring efforts during the past year, and for what I know will be their continued hard work in the year ahead. Every Leonian should consider themselves fortunate to have in our community a group of such dedicated individuals – they have, and will continue, to be the difference between merely having a plan, and having that plan realized.

Lastly, there are not words complimentary enough to recognize the efforts, collaboration and teamwork of the members of the Leonia Borough Council. Councilwoman Davis, Councilwoman Flaim, Councilman Fusco, Councilman Grandelis, Councilwoman Terrell and Councilman Ziegler, you are, without question, the most dedicated group of volunteers with whom I have ever had the honor and pleasure of working. What makes our municipal government work is our shared commitment to community engagement, and to making decisions based on what is best for our community as a whole. We are a team of diverse backgrounds and experiences, and a team with strong opinions – but each of you always brings those opinions to bear in a manner that shows the deep respect we have for one another, and never loses focus on the fundamental desire to get to a solution based on one overarching principle: to do what's right. Whether they know it or not, every Leonia resident is VERY fortunate to be served by such a talented team of elected officials; while I know that we will continue to face significant challenges in the year ahead, I am excited about what I know will be the creative approaches we will together implement to solve them. Thanks to everyone's collaborative efforts, the state of the Borough of Leonia is strong, and our future as a community can only continue to get brighter. Thank you - to everyone who serves our community – for your continued commitment; now, let's get to work."
