

**BOROUGH OF LEONIA
ORDINANCE #2021-14**

**AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 194 OF THE
ORDINANCE OF THE BOROUGH OF LEONIA ENTITLED “VEHICLES AND TRAFFIC”,
SECTION 194.3 ENTITLED “ALTERNATE SIDE OF THE STREET PARKING”**

BE IT ORDAINED by the Mayor and Council of the Borough of Leonia, County of Bergen, State of New Jersey, as follows:

Section 1.

Chapter 194 of the Code of the Borough of Leonia, “Vehicles and Traffic”, Section 194-3 “Alternate Side of the Street Parking” is hereby amended by deleting it in its entirety and replacing it with the following:

194-3 Alternate side of the street parking.

A. Alternate side of the street parking is hereby established on all days on all Borough streets or parts thereof which are more than 29 feet in width, from curb to curb or to the full extent of the improved roadway, in accordance with a list of widths of Borough streets prepared and duly certified by the Chief of Police and kept on file, available for public reference in the Police Department and office of the Borough Clerk. In accordance with this subsection, no person shall park a vehicle on the south and east side of any street from 8:00 a.m. on Tuesday to 6:00 p.m. on Thursday nor on the north and west side from 8:00 a.m. on Friday to 6:00 p.m. on Monday. All times set forth shall be prevailing time.

B. Alternate side of the street parking is hereby established on all days on all Borough streets or parts thereof which are 29 feet or less in width, from curb to curb or to the full extent of the improved roadway, in accordance with a list of widths of Borough streets prepared and duly certified by the Chief of Police and kept on file, available for public reference in the Police Department and office of the Borough Clerk. In accordance with this subsection, no person shall park a vehicle on the south and east side of any street from 8:00 a.m. on Monday to 6:30 a.m. on Thursday nor on the north and west side from 8:00 a.m. on Thursday to 6:30 a.m. on Monday. All times set forth shall be prevailing time.

C. The following Borough streets are exempted from the Subsections A and B of this section only as specifically delineated in this subsection: Bergen Boulevard; Broad Avenue; Glenwood Avenue; Hoefley's Lane; Oakdene Avenue; Lakeview Avenue west of Grand Avenue to the circle; Hillside Avenue between Broad and Grand Avenue; on all Borough streets or parts thereof located within Vreeland Hills, and when special parking restrictions are posted as specifically mentioned in this chapter.

D. It shall be unlawful for any person to cause, allow or permit any motor vehicle to stand or be parked on a street or part thereof other than as posted. A violation of this section shall result in the imposition of a fine of not less than \$25

Section 2.

Chapter 194 of the Code of the Borough of Leonia, "Vehicles and Traffic", Section 194-30 "Schedule I: No Parking", is hereby amended by:

A. Adding the following:

Name of Street/Location	Side
Elm Place/100 feet east of Broad Avenue	North
Magnolia Place/140 feet east of Broad Avenue	North

B. Deleting the following:

Name of Street/Location	Side	Hours/Days
Paulin Boulevard	West	Highwood Avenue to Allaire Avenue
Knapp Terrace	South	Park Avenue to Paulin Boulevard

Section 3.

Chapter 194 of the Code of the Borough of Leonia, "Vehicles and Traffic", Section 194-31 "Schedule II: No Parking Certain Hours", is hereby amended by deleting the following:

Crescent Avenue, between Broad Avenue and Glenwood Avenue	North	Monday 8:00 a.m. through Wednesday 6:00 p.m.
Crescent Avenue, between Broad Avenue and Glenwood Avenue	South	Thursday 8:00 a.m. through Friday 6:00 p.m.
Hillside Avenue between Broad Ave and Grand Avenue	South	Thursday 8:00 a.m. through Friday 6:00 p.m.

Hillside Avenue between Broad Ave and Grand Avenue	North	Monday 8:00 a.m. through Wednesday 6:00 p.m.

Section 4.

Chapter 194 of the Code of the Borough of Leonia, "Vehicles and Traffic", Section 194-32 "Schedule II: No Parking Certain Hours", is hereby amended by deleting the following:

Name of Street/Location	Side	Hours/Days
Crescent Avenue/between Broad Avenue and Glenwood Avenue	South	2 hours/8:00 a.m. to 6:00 p.m.
Gladwin Avenue	Both	2 hours/8:00 a.m. to 6:00 p.m.
Elm Place/100 feet east of Broad Avenue	North	1 hour/8:00 a.m. to 6:00 p.m.
Magnolia Place/106 feet east of Broad Avenue	North	1 hour/1:00 p.m. to 6:00 p.m.

Section 5.

All other provisions of Chapter 194 of the Code of the Borough of Leonia, "Vehicles and Traffic" are hereby ratified and confirmed.


Section 6. Severability
