# Administration

### **Administrator's Report Summary**

- 1. <u>Municipal Building</u> Bid documents for the municipal building were published in January; opening is scheduled for March 1, 2022, 40 Interested Bidders. Met potential State Contract vendor to discuss furnishing options for the new municipal building. A meeting took place to propose vendor for the technology recommendations for the new municipal building, the focus was to review the architectural plans and determine solutions pertinent technology needs related to the new building. The Borough Engineer is working with GZA Environmental on the placement of monitoring wells at the municipal building site.
- 2. <u>Edmunds Financial Software System Conversion</u> finalized the Edmunds financial conversion in late January 2022. Employee training for contract and purchase requisition review took place. Purchase order requisitions were entered and approved via the new system beginning the week of January 31.
- 3. <u>Borough Cyber Security</u> The Municipal Excess Liability Joint Insurance Fund approved the Borough of Leonia's cyber security plan. Administration and Intrep Solutions working on a "continuous phishing campaign assessment" for the Borough of Leonia. The borough has been selected as a select group of first offers by CISA for this continuous phishing format with "rapid enrollment" and automated report deliveries (No cost to the borough).
- 4. <u>It Pay\$ to Plug In NJDEP Grant Application</u>- Grant application has been executed and the Borough can now officially proceed with the construction phase of the electric vehicle charging station. The installation of the dual electric charging station is planned for the Beechwood parking lot & Power source has been determined

- **5. Operating Budget 2022** Updated Operating budget to be presented to the finance committee, a final review with the Auditor planned for March 8. Introduction is scheduled for March 21, and adoption April 18.
- **Capital Budget 2022** Capital Budget Planning Committee Chairman, met with the Administrator to review existing capital projects and their status from the 2021 capital improvement plan year. Discussions took place regarding the 2022-2027 capital budget calendar. Departments being consulted for needs
- 7. <u>DPW Blue Collar Contract Negotiations</u> The Administrator and Borough Labor Counsel met with the RWDSU Local 108 (Blue Collar) Union President & Leonia's DPW representative recently to discuss the next negotiation session & arrived at a mutually agreed upon date.
- 8. <u>Performance Review Software</u> A kick-off meeting was held with NEOGOV Perform implementation representative. NEOGOV Perform is the software package selected by the Borough to conduct employee performance reviews. A timeline with milestones was created with the vendor and regular meetings with training markers were identified.
- 9. Recruitment of DPW Laborer(s) The Borough Administrator is working with DPW on recruitment of DPW Laborer(s). The Administrator will schedule initial interviews for any interested, qualified candidates as quickly as possible as DPW positions are extremely competitive at the present time. Staff will advise the DPW Committee of top candidates at its meeting scheduled for February 15, 2022.
- 10. Recruitment Administrative Assistant to Borough Clerk's Office Interviews for the position of Administrative Assistant to the Borough Clerk's Office have been conducted. We will present the top candidate(s) to the Finance/HR Committee at its next meeting and plan to have a candidate for recommendation to the Mayor and council.
