# Finance, Administration and Personnel

Council President Knott reported that the Committee met and personnel issues were discussed.

### Laws & Ordinances

Discussed pool passes that Swim pool gives out to needy residents. The Committee agrees with the guidelines set by Superintendent Davidson and only 15 passes will be issued.

Naming Parks - Councilman Whitter reported the Committee agrees with the recommendations after the Commission approves the recommendations they will be sent to the Mayor and Council for approval.

Will meet shortly for dimensions of signage.

#### **Police**

Councilman Hawkins read a police report from January to May 2012.

#### **Fire**

Councilman Knott reported that the Fire Department has responded to 35 calls for June and there have been 180 call so far for the year.

#### **Ambulance**

Councilman Pak read the report from Englewood Hospital. Councilman Pak inquired as to the increase in response time. Mr. Terhune explained the ambulance is not always "sitting" in Leonia some days it may be in Palisades Park, and the response time would increase.

#### **Public Works**

Councilman Choi did not have a report from the DPW.

#### Administrator

Mr. Terhune reported the basketball backboards and nets were improperly installed and were removed on Friday. The large playground in Wood Park is going to be resurfaced. The Leonia Market is scheduled to open on Thursday, June 29th, at 9:00 AM.

Mr. Terhune reported he is in the process of developing a Cooperative Pricing package for the surveillance cameras. There will be three other municipalities involved, Palisades Park, Cliffside Park and Englewood Cliffs. Councilman Pak reported that one of the pieces of equipment in Wood Park has a piece of duct tape over a damaged area.

Councilman Choi inquired about the Fort Lee settlement. Mayor DeSimone reported that he and Mr. Giblin met with Mayor Sokolich and the Borough Attorney from Fort Lee to settle the issues. Leonia residents and merchants will be allowed to pass through the barricades. Fort Lee Police will give as much notice as possible of any closures that may occur.

## Mavor

Mayor DeSimone on a meeting he attended regarding the use of surveillance cameras. The cost of the cameras will be less than he originally thought they would be.

Mayor DeSimone attended the Sports Boosters dinner dance over the weekend.

# Special Bodies

Councilman Whitter - Economic Development committee has held two meetings the next meeting is scheduled for July 24th. The Committee is looking at several properties around the Borough for development.

Councilman Pak - Recreation Commission - Swim Pool membership up. The summer camp program will have a food program this year. The third and fourth grade girls won the softball championship. Recreation ceiling has falling paint, Borough Administrator is meeting with engineer/and Superintendent Barbara Davidson to see what can be done.

Background checks have been done all are good

Councilman Knot - Historic Preservation Mr. Roynon suggested that a local artist be used for the calendar. Mr. Terhune explained the Board of Education generally selects artwork that is used.
