STANDING COMMITTEES

Finance, Administration and Personnel

Councilman Knott - no recent meeting to report about, but the CFO is working on the budget. At the same time Councilman Knott advised the Governing Body that there are several personnel issues at hand but the Committee is not prepared to discuss them at this time.

Another issue that has come up is Councilman Whitter, Councilman Hawkins, and Councilman Knott recently met with the Meadowview Condominium Association, in relation to the reimbursement the Borough gives to the Association. For example: hydrants, lights, snow removal, leaf removal, etc.

The Councilman suggested that the Association supply the Governing Body with a breakdown of what they are paying currently and the Personnel & Finance Committee will review it.

The original agreement was from the year 2000, and it was reviewed in 2008. They feel the amount is inadequate to compensate for the out goings. The Committee will meet to come up with a solution that satisfies both, the Association and the Borough which may require a new agreement and resolution.

Subject: Synopsis of Leonia Police Operations- January to November 2012

Date: December 17, 2012

The following is a synopsis of our operations for January through November 30, 2012.

Calls for Service- 10,300

Burglaries-39

Motor Vehicle Accidents -260

Motor Vehicle Summonses Issued- 5,150

<u>Crime Rate:</u> The New Jersey State Police released their 2011 Crime Report statistics on December 15, 2012. In 2011 Leonia's crime rate increased by 79%. The increase is mostly attributable to the significant rise in burglaries from 19 to 43.

<u>Staffing:</u> There are currently 17 Police Officers in the Leonia Police Department. Our staffing ratio is 1.91 Officers per 1,000 residents. The average staffing ratio for Bergen County municipalities is 2.2 officers per thousand residents. Using the County average Leonia should have 20 Police Officers.

SRO: I have previously advocated for a School Resource Officer for our school district. A School Resource Officer is a regular police officer assigned to the schools; responsible for school safety, DARE, relationship building, and serving as the juvenile officer. The recent events in Newtown CT highlight the need for not only additional police officers for the department as a whole but specifically for a police officer assigned to the school. The cost for such an officer for a three year period is approximately \$225,000.00. This would cost the average Leonia taxpayer \$25.00 per year to fund this position.

<u>Police Station</u>: The Police facility continues to be unsafe, in violation of various State and Federal Laws and wholly inadequate as a police station. Plans should commence immediately for its replacement.

School Violence/Workplace Violence: The Leonia Police Department has been well ahead of the curve in regards to training to combat an active shooter event such as the most recent one in Newtown CT. I have personally developed and implemented an Active Shooter Training Program for the Leonia Police Department. All of our police officers have been trained through this system. Several of our officers have attained Active Shooter Instructor Certification through the National Tactical Officers Association. Many of our officers are certified Firearms Instructors, Assault Rifle Instructors, and Simunition Instructors. We continuously train in our schools and are prepared to intervene effectively should such a horrible event ever happen in our community. We have worked with the schools on developing their physical security and on developing the operating procedures they would use in a crisis.

Borough Administrator Terhune extends his thoughts and grief for the parents and residents of Newtown Ct. In all of his years in

Law Enforcement and Government he has never read, seen, witnessed anything as horrific that occurred on Friday in Newtown Ct. Our prayers and condolences go out to the whole community.

At this time the Administrator commends Sgt. Tamagny, Palisades Park Police Offices, DeSotto, and Lee all of whom responded to a very delicate and difficult situation two (2) weeks ago on Sunday. No other comment can be made because of the ongoing investigation.

At this time Administrator commended Acting Borough Clerk for her ability to learn and grasp the new system (IQM2). Several residents have commented on the fact that they can easily obtain the agenda, minutes, and watch the video of the meeting.

On another note, the roof on the rec center is half done, the painter for the ceiling has started the inside work and has 2 weeks to finish.

Suggested the Governing Body review the meetings schedule for 2013. At the same time needs some tentative dates for a special meeting concerning disciplinary hearing for a Borough employee.

In ending, the Administrator hopes that the Governing Body and residents of the Borough of Leonia have a very safe and happy Holiday.

Recreation - Councilman Pak

The following is a report that Councilman Pak read from Superintendent Davidson:

A synopsis of last night's meeting for your review.

- 1. The rates for the credit card fees were dropped due to the diligence of the CFO. This rate will lower our credit card fees for both pool and recreation programs.
- 2. The recreation roof will be starting this week and the ceiling will begin to be repaired and painted immediately after. All work needs to be done on or before January 14th.
- 3. The proposed ice Rink is on a hold for opening until the weather drops below 40 degrees. Will be constructed by Commission and placed in Wood Park on the softball infield.
- 4. A lot of time was spent on the Parks Walk review and all items found on your review in packet are being handled by the DPW and Rec. Staff.
- 5. The Commission voted unanimously to host the elections for 2013 if it is the wish of the Council and the Board of Elections.
- 6. The Commission holiday party will be at Dante's this year, November 18th, spouses invited, and the Mayor and Mr. Terhune are invited as well. It is a pay as you go and BYOB.
- 7. The Lighting detection System was reviewed and the Commission believes more information needs to be seen before signing with any one company. The cost is prohibitive at this point to split between Borough and BOE.

Library - Councilman Pak

Library, Budget went up by 1.9% which includes benefits.

Betty Carillo's term is up, wants to be reappointed but because of by-laws she is unable to be the chairperson. Thank the Governing Body for their support for the last several years as library Chairperson.

Councilman Hawkins mentioned that the permits have been approved for the Overpeck preserve.

Councilman Knott - commended the Recreation Department for the outstanding work that was done for the annual tree lightning.

Councilman Knott agrees with Councilman Hawkins, but believes that no Ordinance is written in stone. If the Governing Body finds this Ordinance is a problem they can always revise it and go back to having two boards again. No ordinance is irreversible.
