# Department of Public Works (D.P.W.)

### Overview – April 2023

During the month of April 2023, the Department of Public Works continued its regular programs of garbage and trash collection, recycling, street and road repairs, sewer services, tree maintenance, and repairs.

### **Yard Waste**

Yard waste collections started on March 6th, 2023. All yard waste must be bundled and tied together with branches no longer than 4 feet in length. All other debris must be put in ridged 32-gallon or fewer containers or brown biodegradable paper bags. No items can be more than 50 pounds in weight. No plastic bags can be used yard waste will not be collected.

# All items MUST be out for collection before 7:00 am the day of its scheduled collection day.



- The department continued to work with the representatives from the Mental Health event to be held in Wood Park on May 7, 2023.
- Also, we have been working with the Fire Department with their 125th Anniversary event to be held on May 6th.
- Baseball season has begun and the department is maintaining the ballfields weather permitting.
- The department welcomed back employee Adam Jurek who returned from family leave after the birth of his daughter.
- ❖ The department assisted with a paper shredding event at Borough Hall which included documents from Borough Hall, Recreation Department, and Public Works approved for removal from the records.
- Superintendent Villareal and Assistant Superintendent Malloy attended a webinar on Storm Water training on April 21st. 2023. This class covered a vast amount of information on Storm Water regulation, the inspection process, and design aspects of the construction of various water retention systems.
- Superintendent Villareal submitted the 2022 Recycling tonnage report to the NJDEP for last year's tonnage amounts.

#### **Training – April 2023**

- The Department completed Attorney General mandated training on Use of Force.
- April 10th, active shooter training was conducted at the Leonia Middle School with Ridgefield Police Department and Bergen County Regional SWAT. Leonia School Acting Superintendent Xanthy Karamanos was also in attendance.

#### **Community Outreach**

- April 22nd, Leonia Police Department participated in the DEA's National RX Takeback program. The Department accepted unwanted prescription medication from the public. The collection helps prevent the abuse of medications and protects the environment from improper disposal.
- ❖ PO Cho has been instructing the LEAD program to 5th grade classes at Leonia Middle School.

#### **Additional News**

- ❖ The Leonia Police Department received a grant in the amount of \$7,000 from the NJ Division of Highway Traffic Safety. From April 1st to April 30th, the Department participated in the statewide distracted driver enforcement campaign, "UDrive. UText. UPay". 100 hours of extra patrols were scheduled for every Sunday during the month of April resulting in 182 summonses and 2 arrests.
- ❖ On January 18th and January 26th, two robberies were committed in Leonia. The robberies were almost identical, the victims were selling Rolex watches on a Chinese website and the suspect met the both victims in Leonia. The suspect pepper sprayed the victims and robbed them of their watches. After a thorough investigation, a warrant was issued for the suspect's arrest. The suspect, Zeyu Ding (19yr old male from Queens, NY) was arrested last month in Pennsylvania. He was extradited to New Jersey on April 21st and released pending Court. The robberies are still under investigation and additional arrests are pending.
