# Ordinance 2023-15 Amend Chapter 46 – "Personnel Policies"

The Borough Clerk read the title of the ordinance into the record:

"AN ORDINANCE TO AMEND CHAPTER 46 OF THE GENERAL CODE OF THE BOROUGH OF LEONIA ENTITLED "PERSONNEL POLICIES""

Borough Attorney Chewcaskie provided a history of the personnel policy and its various recent changes. The Ordinance being proposed adds to Chapter 46 and indicates that personnel policies shall be adopted by resolution on an as-needed basis. The Borough Attorney suggests that a resolution be passed annually during reorganization to ratify and reaffirm the personnel policy.

Mayor Zeigler requested that a change be made to correct the erroneous listing of the Borough Administrator title as Business Administrator.

Councilman Hesterbrink inquired as to Chapter 46 listed within the ordinance and was answered by Borough Attorney Chewcaskie.

# Unfinished Business

# RV, Commercial Vehicles, and Licenses – Joanne Terrell / Brian Chewcaskie

Borough Attorney Chewcaskie explained that what can be parked at a single-family home is regulated by zoning. Currently, RV's and Commercial Vehicles of a certain size are permitted to be parked in single-family zoning, with the provision that a 5-foot screen be in place to hide it. The discussion that was held over this emanated from the use of one of the municipal lot parking spaces to store an RV.

The question that is to be asked is whether or not the Borough of Leonia wishes to permit commercial vehicles or RVs to continue to be parked in residential zones. In addition, it must be decided whether commercial vehicles or RVs should be permitted to park in the municipal parking lot, and if so, it is suggested that those fees be increased to correspond to the size of the vehicles. Through a conducted study it was found that the Borough of Leonia is currently undercharging for those fees and it is the suggestion of the committee to raise these fees if parking is to be permitted.

Mayor Zeigler stated that the items to be considered as follows:

- 1. Is there the desire to have items other than residential vehicles be allowed to be stored in the municipal parking lots?
- 2. Is there an agreement as to a new fee structure?

Councilman Hesterbrink questioned whether there was a distinct problem that was the impetus of this discussion as currently the size of vehicles is limited based on the availability of spots.

Mayor Zeigler replied that the question lies in that as more residents have started to work from home there are a larger number of vehicles using the lot than before, and a discussion was started to determine whether commercial vehicles and RVs should be prohibited to lessen the strain. It is not necessarily a problem but a desire to look at the current provisions set by the ordinances in the Borough Code and update them with the changing needs of the community.

Councilwoman Terrell stated that there has been an increasing number of requests to park RVs in the municipal lot as well as from residents in apartment buildings with not enough parking. The desire for this discussion is to be responsible with ordinances and determine if there is adequate enforcement.

Councilman Hesterbrink inquired as to whether there was adequate parking within the lot to accommodate the demand. Mayor Zeigler responded that he would agree with the assessment that the use of the lot has increased and thus it is stretched for capacity.

Councilwoman Davis explained that there are alternatives that are available for RV owners for parking and that she is in agreement that parking within the municipal lot should be reserved for residential vehicles only.

Police Chief Tamagny questioned the number of permits that have been issued and that the current ordinance limits the weight of vehicles within the lot to 9 tons.

Councilman Ziegler stated that he is not in favor of RVs, buses, and other oversized vehicles parking within the lot as it is owed to residents first to make regular vehicle spaces available.

Mayor Zeigler confirmed that the Council desired to amend the ordinance to remove RVs and other large commercial vehicles from being authorized to park in the municipal lot.

Further discussion was held as to enforcement and the proposed update to the Borough Code.

Borough Attorney Chewcaskie explained that after he reviewed Limousine Licensing, it was discovered that by state statute the Borough of Leonia is charging what is permitted. The business itself could potentially be charged an additional fee for a business license but the Borough Attorneys recommended against it.

# Public Comment

Lydia Maurice, 392 Grand Avenue, told a story of how the multiple diverse communities of Leonia are bridging together. Ms. Maurice also wished to know what services would be held at 2 Christie Heights Street. Mayor Zeigler replied that it is a private business and that further questions be asked at the Planning Board. Further information was provided to Ms. Maurice by the Chair of the Planning Board, Michael DeGidio.
